EURAS is pleased to share with you an amazing opportunity from Mustafa^(pbuh) Science and Technology Foundation (MSTF)! With the aim of capacity building and nurturing the young generation for the development of science, technology, and innovation in line with the values and needs of the Islamic society, MSTF and COMSTECH have jointly initiated the Young Scientists' Fellowship Program (YSFP) to support talented youth with the cooperation of prestigious scientific institutes and reputable R&D centers.

YSFP provides short-term fellowships to young scholars, technologists, and faculty members under 45 years of age. Applicants must hold at least master's degree. Duration of fellowships in this program is 6-12 months, which can be more or less depending on the conditions and requirements, with the agreement of the host.
